



EXPORT SERVICE FEE SCHEDULE *for exports to CANADA*

FIREARMS

\$249 for the first gun, + \$99 for each additional gun on the same export transaction.
+ 5% of the value of the exported merchandise
Email for a quote for quantities of 8 or more.

AMMUNITION, PARTS, COMPONENTS, ACCESSORIES, OPTICAL SCOPES

\$149 for the first line item, \$75 for each additional line item on the same export transaction.
+ 5% of the value of the exported merchandise
Email for a quote for quantities of 10 or more different line items.
Note: shipping of *ammunition* from the U.S. into Canada in small quantities is expensive.

BORDER DELIVERY / SHIPPING

\$75 Border Delivery to Aldergrove, BC border crossing (rather than shipping if you live close)
Shipping Costs Vary - Average \$50 to \$100 for a rifle and case, \$50 for a pistol and case.
Non-ammunition items can usually be mailed directly via U.S. Postal Service / Canada Post.
Customer is responsible for all shipping & insurance costs, billed at actual rates.

TAXES / DUTIES

Customer is responsible for all taxes & duties levied by Canada Revenue Agency.
Includes any applicable provincial and/or federal sales taxes (ie GST, PST or HST).
Duty may be charged on items manufactured outside of the U.S.A., most often at a 3.5% rate.

BORDERVIEW LLC is registered with the U.S. Department of State as an Exporter of USML Category I Defense Articles, and with the U.S. Department of Commerce as an Exporter of Shotguns and related articles. All exports are subject to the prior approval of the appropriate federal agencies. Export Service Fees, as listed above, are due prior to application, and regardless of the response of the pertaining agency (delivery/shipping expenses are, however, refundable). Employees of BORDERVIEW LLC will give their best opinion on the feasibility of an export, but in no case is this a substitute for law or the actual decision of the U.S. Government. Merchandise orders placed through Dave's Sports Shop require full payment prior to Export License application. The U.S. Dept. of State requires 4-6 weeks for export licensing decisions. The "5% Upcharge" portion of the Export Service Fee goes to the U.S. Department of State as part of our Registration fees. All prices are listed in US Dollars. Canadian-side customer (importer) is responsible for (1) obtaining an International Import Certificate ("IIC") from Foreign Affairs & International Trade Canada ([instructions link](#)) ([application link](#)), (2) issuing a Purchase Order stating their desired purchase, whether directly from Dave's Sports Shop, or a transfer of a firearm purchased through another U.S. seller, and (3) for complying with all Canadian importing, possession, transportation, storage and acquisition laws, including registering of the firearm in the Canadian Firearms Centre database and possession of a current Possession and Acquisition License (PAL).
